" RESOLUTION NO. 97-03-040

AUTHORIZING THE MUNICIPAL TREASURER TO DISBURSE THE NECESSARY AMOUNT FOR THE PAYMENT OF SALARY INCREASES OF MUNICIPAL OFFICIALS AND EMPLOYEES GRANTED UNDER EXECUTIVE ORDER NO. 389, SUBJECT TO SUCH IMPLEMENTING RULES AND GUIDELINES PRESCRIBED UNDER LOCAL BUDGET CIRCULAR NO. 64, DATED 22 JANUARY 1997

"WHEREAS, the Municipality of Bulalacao has appropriated the amount of One Million Two Hundred Fifty Thousand Pesos (P1,250,000.00) for 1997 increase in the salaries of its officials and employees pursuant to Senate-House of Representatives Joint Resolution No. 01, Series of 1994, and Republic Act No. 6758;

"WHEREAS, said Joint Resolution No. 01 and adopted under Executive Order No. 389, dated December 28, 1996, authorized the final increase into two (2) payments:

- 1) Effective January 1, 1997 equivalent to fifty percent (50%) of the unimplemented balance as of December 31, 1996, of the basic pay corresponding to the Salary Grade concerned, and
- 2) Effective November 1, 1997 the remaining fifty percent (50%) of said unimplemented balance to effect full salary adjustment;


"WHEREAS, the Department of Budget and Management is directed under EO 389 to implement the said increase and to prepare and issue the necessary guidelines for its implementation; Now, therefore, be it

RESOLVED, AS IT IS HEREBY RESOLVED, To: Authorize the Municipal Treasurer to disburse the necessary amount for the payment of salary increases of municipal officials and employees granted under Executive Order No. 389, subject to such implementing rules and guidelines prescribed under Local Budget Circular No. 64, dated 22 January 1997;


