EARNESTLY REQUESTING HONORABLE MANUEL S. MORATO TO ASSIGN
ONE PHYSICIAN AND ONE NURSE TO BULALACAO COMMUNITY HOS-
PITAL, BULALACAO, ORIENTAL MINDORO, ALLOCATING FUNDS
THEREFOR

"WHEREAS, it was a dream come true for the people of
Bulalacao, Oriental Mindoro when the first and only Commu-
nity Hospital established in this Municipality was finally
inaugurated on October 25, 1996;

"WHEREAS, the operation of the mentioned hospital
was able to provide essential and basic medical services
to the Twenty Four Thousand inhabitants although hampered
by inadequate medical facilities and medicines necessary
for a more effective and efficient medical treatment;

"WHEREAS, considering the number of patients to be
attended, the Hospital which at present is manned by a
single physician, three nurses and three midwives finds
it difficult to accomodate them all especially during the
occurence of emergencies where immediate medical atten-
tion is absolutely necessary;

"WHEREAS, it would be to a great extend helpful if
the medical staff of Bulalacao Community Hospital would
be augmented by at least one more physician and a nurse;

"WHEREAS, the Provincial Government of Oriental Min-
doro to whom the responsibility of operation and mainte-
nance are devolved is hounded with financial constraint
thus, an assistance from the PCSO shall be highly
valuable; Now, therefore, be it
