EARNESTLY REQUESTING DIRECTOR JESUS M. INGENIERO, REGIONAL OFFICE IV, DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT TO PROVIDE THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO WITH THE NECESSARY SPORTS PARAPHERNALIA TO BE USED ON THE CONDUCT OF IGULYMPICS

"WHEREAS, the IGUlympics, a community based multi-level special sports competition open to all sectors, is designed to improve the quality of life of Filipinos, protect and promote their social, physical and mental well-being through physical fitness and sports competition, thus enhance community participation and people empowerment;

"WHEREAS, it likewise provides equal access to and opportunity for all, thus ensure the proper selection process for the identification, recruitment, and training of new talented athletes from the community level;

"WHEREAS, in compliance with DILG Memorandum Circular No. 96-178 enjoining all IGUs to implement their respective year-round community-based physical fitness, sports and recreation program, this Municipality plans to conduct its IGUlympics during this summer period;

"WHEREAS, it is feared that success of such sports event could be affected by the very limited financial resource of this Municipality;




- a. 16 pairs of boxing gloves

- e. 32 volleyball nets and balls.


