REQUESTING THE HONORABLE SALVADOR M. ENRIQUEZ, JR., SECRETARY, DEPARTMENT OF BUDGET AND MANAGEMENT TO FURNISH THIS OFFICE WITH LIST OF PROJECTS FUNDED BY THE NATIONAL GOVERNMENT FOR THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO FOR CALENDAR YEARS 1996 AND 1997

"WHEREAS, it is learned that there are several national projects intended for the Municipality of Bulalacao, Oriental Mindoro in the previous years which were not duly coordinated with the Local Government;

"WHEREAS, there are reports that such projects were already done in completion which this Sanggunian doubts as to the veracity of such reports;

"WHEREAS, if indeed, there were projects duly funded by the government and were not completed, proper government agencies must look into it as this senseless deception is viewed by the people of this Municipality as a blatant betrayal of public trust;

"WHEREAS, particularly odious and revolting to the people sense of propriety and morality in government service were the lost opportunities to take advantage of the projects had they been really completed;


"WHEREAS, it is understood that DBM has on its records the list of projects funded by the national government for the benefits of the local government units;
