EARNESTLY REQUESTING THE HONORABLE MANUEL G. ANDAYA, CONGRESSMAN, ORIENTAL MINDORO, DISTRICT-II, HOUSE OF REPRESENTATIVES, TO PRIORITIZE THE CONCRETING OF BARANGAY BAGONG SIKAT BRIDGE SITUATED IN BARANGAY BAGONG SIKAT, MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO

"WHEREAS, Barangay Bagong Sikat Barangay Road remains to be unpassable by land transportation especially during rainy season wherein it becomes rugged and muddy;

"WHEREAS, aside from the sorry road condition, the bridge at that barangay which is temporarily built of wood appeared to be dangerous to cross which endangers the lives and properties of the inhabitants particularly during the onslaught of the bad weather condition;


"WHEREAS, it is believed that with the repair and rehabilitation of the transportation system at that barangay, trade and commerce would prosper, considering that a large volume of various agricultural products come from Barangay Bagong Sikat, which would eventually uplift the socio-economic condition of the residents therein; Now, therefore, be it
