REQUESTING THE HONORABLE RODOLFO G. VALENCIA, PROVINCIAL GOVERNOR, TO DEFER ANY APPOINTMENT TO THE SEAT VACATED BY THE LATE COUNCILOR RESTITUTO J. CEZAR

"WHEREAS, there occurs permanent vacancy in the Sangguniang Bayan of Bulalacao, Oriental Mindoro caused by the death of one of its regular member, Councilor Restituto J. Cezar;

"WHEREAS, it is stipulated under Section 45 of the Local Government of 1991, permanent vacancy in the Sangguniang Bayan shall be filled by appointment by the Provincial Governor concerned;

"WHEREAS, it is considered by such vacancy would not hamper the workings of the Sangguniang Bayan in its exercise of the powers, duties and responsibilities vested on it;

"WHEREAS, it is also the considered view of this Sanggunian shall save the municipal government with money which it badly needs to finance the implementation of basic social services; Now, therefore, be it
