'WHEREAS, at present, the association is in need of funds to enhance its objective of providing its members a chance to venture to any livelihood projects that will generate additional income for the family;


'WHEREAS, it is learned that the Honorable Susan Cobrado supported various livelihood related programs that this request will merit her preferential attention; Now, therefore, be it






