
"WHEREAS, the Municipality of Bulalacao needs to promote development in its 15 component barangays to uplift the quality of life of its inhabitants;


"WHEREAS, to realize this objective, the Municipality needs financial assistance from all possible sources particularly the Provincial Government; Now, therefore, be it


