EARNESTLY REQUESTING THE HONORABLE TESSIE AQUINO ORETA, SENATOR, REPUBLIC OF THE PHILIPPINES TO ALLOCATE THE NECESSARY FUNDS FOR THE CONSTRUCTION OF ONE UNIT THREE (3) CLASSROOM BUILDING FOR BANGKAL ELEMENTARY SCHOOL LOCATED IN BARANGAY SAN JUAN, BULALACAO, ORIENTAL MINDORO

"WHEREAS, it is a Constitutional mandate that the State shall assign the highest budgetary priority to education and that quality and basic education be made available to all;

"WHEREAS, Bangkal Elementary School in Barangay San Juan needs additional classroom buildings to house and accommodate the increasing enrollees thereat approximately reaching to 300 pupils with more than 50 in a room;
