WITHDRAWING THE MUNICIPALITY OF BULALACAO'S PARTICIPATION-BATCH 2 AND THE REMAINING BATCHES IN THE JAPAN BANK FOR INTERNATIONAL COOPERATION-FUNDED RURAL WATER SUPPLY AND SANITATION PROJECT PHASE V (PROVISION OF LEVEL I WATER SUPPLY FACILITIES, SCHOOL TOILETS AND PUBLIC TOILETS)

"WHEREAS, the applicability and demand for level 1 water facility are low in target communities compared to the situation when the project was conceptualized and initiated four to five (4-5) years ago, with the present demand of the populace more on Level II (communal faucet) and Level III (house to house connection) water system;

"WHEREAS, the strict PROJECT SITE SELECTION CRITERIA limit target communities to qualify and participate;




"WHEREAS, the project is not financially viable due to its high cost of construction and civil works, Now, therefore, be it


