AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO CONTRACTUAL AGREEMENT WITH JOSE JOEMER HARI-ON, REPRESENTATIVE, WISPEA ENTERPRISES WITH OFFICE ADDRESS AT #15 LEDESMA COURT EXTENSION, VISAYAS AVENUE, QUEZON CITY FOR THE ACQUISITION OF ONE (1) UNIT OF D85-A KOMATSU BULLDOZER, SURPLUS ACQUIRED FROM JAPAN IN VIEW OF THE TWO (2) CONSECUTIVE FAILED BIDDINGS THEREOF
