EARNESTLY REQUESTING THE PHILIPPINE HEALTH INSURANCE CORPORATION (PHILHEALTH), REGIONAL OFFICE, REGION IV-B, BATANGAS CITY TO CONDONE THE PAYMENTS OF PHILHEALTH CONTRIBUTIONS DERIVED FROM BUSINESS ESTABLISHMENTS STARTING JULY 3, 1999 UP TO DECEMBER, 2003
