**RESOLUTION NO. 04-02-021**

**APPROVING THE BARANGAY FUND ANNUAL BUDGET FOR FY 2004 OF BARANGAY MILAGROSA, BULALACAO, ORIENTAL MINDORO APPROPRIATING THE AMOUNT OF SIX HUNDRED TWENTY FOUR THOUSAND THREE HUNDRED EIGHT PESOS (Php624,308.00) PASSED UNDER RESOLUTION NO. 2 AND APPROPRIATION ORDINANCE NO. 2004-01 DATED FEBRUARY 13, 2004**

**"WHEREAS**, Section 57 and Section 447 par (ii) empower the Sangguniang Bayan to review all ordinances passed by the Sangguniang Barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and not to be inconsistent with law or municipal ordinance;

**"WHEREAS**, the Sangguniang Barangay of Milagrosa, Bulalacao, Oriental Mindoro submitted its Barangay Fund Annual Budget for FY 2004 showing therein the sources of income and barangay expenditures starting from January 1, 2004 up to December 31, 2004;




"WHEREAS, it is therefore understood that disbursement of appropriation shall be guided by existing COA rules and regulations; Now, therefore, be it
