RESOLUTION NO. 06-12-107

DECLARING THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO UNDER THE STATE OF CALAMITY

"WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro suffered extreme and various losses in agricultural produce, livestock and fishing industries and other related damages caused by Super Typhoon Senyang that occurred on December 10, 2006 which brought distress, hunger, deep grief and misfortune among its inhabitants;

"WHEREAS, Typhoon Senyang ruined several (transportation and communication facilities), houses and other building structure were totally destroyed which resulted to social and economic turmoil of the people particularly those poor and helpless residents who were greatly affected by this natural calamity;

"WHEREAS, there is a need to restore the normal living conditions of the community who were badly damaged by Typhoon Senyang through the disbursements of the 5% Calamity Fund intended for the purpose stated herein;


"WHEREAS, pursuant to the Rules and Regulations Implementing Republic Act No. 8185 "An Act amending Section 324 (d) of Republic Act No. 7160 provides that the Sangguniang Bayan concerned may declare the area affected by the calamity under the State of Calamity; Now, therefore, be it
