EARNESTLY REQUESTING THE HONORABLE ARNAN C. PANALIGAN, PROVINCIAL GOVERNOR TO LEND THE SERVICES OF DUMPTRUCKS AND TO PROVIDE CONCRETE AGGREGATES TO BE USED FOR THE GRAVELLING OF FARM TO MARKET ROADS AT THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, the construction and rehabilitation of farm to market roads at the Municipality of Bulalacao is the primary concern of the present Administration in order to facilitate the movements of people and shipment of various agricultural and marine products coming from different barangays;
