**RESOLUTION NO. 05-11-157**

AUTHORIZING THE MUNICIPAL MAYOR, HONORABLE ERNILO C. VILLAS TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE NATIONAL POLICE REGARDING THE DONATION OF A PARCEL OF LOT CONTAINING AN AREA OF 533 SQUARE METERS TO BE EXCLUSIVELY DONATED FOR THE SOLE PURPOSE OF USING IT; WHEREIN A POLICE STATION WOULD BE ERECTED AND BE USED AS AN OFFICE

"WHEREAS, the Municipality of Bulalacao had acquired a parcel of land containing an area of 1,120 square meters situated at Barangay Poblacion, Bulalacao, Oriental Mindoro by way of purchase from certain Mr. Nestor A. Gonzales to be used as site for the Social Services project of the Municipality;


"WHEREAS, such Deed of Sale was entered into on July 31, 2003 by and between the former Municipal Mayor, Gemma G. Salas and Mr. Nestor A. Gonzales and was subsequently ratified by the Sangguniang Bayan on August 4, 2003; and through a letter of request by the new Municipal Mayor dated November 17, 2005 asking that he be authorized to donate 533 square meters in favor of the Philippine National Police Office of this town;


"WHEREAS, convinced that the same effort shall reflect the original intent of the previous Sanggunian and the Executive Branch and likewise understanding the necessity for our Police Enforcers to have their own Office and Headquarters, this Body considered its prudent that they be provided with the opportunity to have a house and Office of their own; Now, therefore, be it


