RESOLUTION NO. 05-11-155

RESOLUTION APPROVING THE INTENT OF THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO OF ACQUIRING SEVEN MILLION FIVE HUNDRED THOUSAND PESOS (PHP7.5M) LOAN FROM LAND BANK OF THE PHILIPPINES, ROXAS BRANCH TO BE USED FOR THE PURCHASE OF HEAVY EQUIPMENTS IN THE AMOUNT OF PHP6M AND FOR THE CONSTRUCTION AND REHABILITATION OF SAN JUAN FARM TO MARKET ROAD CONSISTING A DISTANCE OF 7.060 KILOMETERS IN THE AMOUNT OF PHP1.5M IN ACCORDANCE WITH THE LOCAL DEVELOPMENT PLAN AND ANNUAL INVESTMENT PLAN OF THIS TOWN


“WHEREAS, in its effort to fast tracks the construction and completion of various infrastructural projects included in its Annual Investment Plan (AIP) and Local Development Plan, the Municipal Government of Bulalacao, oriental Mindoro intends to acquire loan from Land Bank of the Philippines, Roxas Branch in the amount of Seven Million Five Hundred Thousand Pesos (Php7.5M) to be used for the purchase of heavy equipments and construction and rehabilitation of San Juan Farm to Market road (7.060 km.) in the amount of Php6M and Php1.5M respectively;


“WHEREAS, it is believed that the successful implementation of the programs mentioned above would hasten all infrastructural projects identified under the Annual Investment Plan and Local Development Plan of this Municipality; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Approve the intent of the Municipality of Bulalacao, oriental Mindoro of acquiring Seven Million Five Hundred Thousand Pesos (Php7.5M) loan from Land Bank of the Philippines, Roxas Branch to be used for the purchase of heavy equipments in the amount of Php6M and for the construction and rehabilitation of San Juan Farm to Market Road consisting a distance of 7.060 kilometers in the amount of Php1.5M in accordance with the Local Development Plan and Annual Investment Plan of this town;


