"WHEREAS, it is a Constitutional mandate that the State shall assign the highest budgetary priority to education and that basic and quality education be made accessible to all;

"WHEREAS, the Bulalacao National High School Main Campus situated in the Municipality of Bulalacao, Province of Oriental Mindoro is in dire need of additional schoolbuildings in order to accommodate the increasing enrollees by 25% this coming School Year;
