"WHEREAS, Section 17 Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that local government units shall likewise exercise such other powers and discharge such other functions and responsibilities necessary, appropriate, or incidental to efficient and effective provision of basic services and facilities such as infrastructure facilities intended primarily to service the needs of the residents of the municipality and which are funded out of municipal funds including roads and bridges;

"WHEREAS, Barangay Cambunang, Bulalacao, is a vast agricultural land producing large volume of rice, corn, garlic, onion and different varieties of vegetables and fruits transported to nearby provinces and in Metro Manila;


"WHEREAS, the said footbridge connects constituents from Sitio Luggis to Barangay Proper of Cambunang and helps the farmers facilitate the immediate transport of their farm produce, thus mounting the income of these farm cultivators;


