RESOLUTION NO. 10-07-048

REQUESTING THE HONORABLE REYNALDO V. UMALI, CONGRESSMAN, 2ND DISTRICT, ORIENTAL MINDORO TO INTERVENE AND FACILITATE THE REMITTANCE OF INSURANCE PREMIUMS OF BARANGAY OFFICIALS TO THE GOVERNMENT SERVICE INSURANCE SYSTEM (GSIS) BY THE NATIONAL GOVERNMENT

"WHEREAS, Section 6 of Republic Act No. 6942 states that the National Government of the Republic of the Philippines shall appropriate annually and include in the General Appropriation Act the annual insurance premiums of barangay officials and the total annual premiums shall released and paid directly to the Government Service Insurance System (GSIS) during the first month of every calendar year;

"WHEREAS, based on our record, there were three barangay officials who died while in government service but unfortunately none of their families received any benefits from the GSIS out of the insurance mandated by R.A. 6942;

"WHEREAS, when these three barangay captains died, their families prepared and submitted all pertinent documents to the GSIS for funeral and death claim benefits but to their dismay, the GSIS returned all those documents citing therein that it will not be approved and released due to the Temporary Suspension per Board Resolution No. 332 dated November 21, 2001 for non-remittance of insurance premiums to the GSIS by the National Government;

"WHEREAS, considering that barangay officials received honorarium only, it will be a consolation to their bereaved family if the insurance benefits which will be used for funeral expenses be paid to them in times of death of their loved ones who spent several years of their life in public service; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Request the Honorable Reynaldo V. Umali, Congressman, 2nd District- Oriental Mindoro to intervene and facilitate the remittance of insurance premiums of barangay officials to the Government Service Insurance System (GSIS) by the National Government;


RESOLVED FURTHER, To: Let copy of this resolution be furnished the Provincial Chapter President of the Liga ng mga Barangay for his information and support;


