### RESOLUTION NO.12-08-058

**EARNESTLY REQUESTING THE HONORABLE ALAN PETER CAYETANO, SENATOR, REPUBLIC OF THE PHILIPPINES TO ALLOCATE THE NECESSARY FUNDS FROM HIS PRIORITY DEVELOPMENT ASSISTANCE FUND (PDAF) TO BE USED FOR THE CONSTRUCTION OF 3-CLASSROOM BUILDING AT SAN ROQUE NATIONAL HIGH SCHOOL, BANGKAL ANNEX SITUATED IN BARANGAY SAN JUAN, MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO**

**"WHEREAS,** it is a Constitutional mandate that the State shall assign the highest budgetary priority to education and that basic and quality education be made available to all;

**"WHEREAS,** San Roque National High School, Bangkal Annex situated in Barangay San Juan, Bulalacao, Oriental Mindoro is in dire need of classroom building to accommodate enrollees thereat who are suffering from difficulties and inconvenience of a dilapidated and temporarily built classroom building since its establishment two years ago;

**"WHEREAS,** the establishment of the above-mentioned school was triggered by the desire of this Administration to get all possible means to provide education to far-flung barangays that shall redound to the social and economic benefits of both the pupils and the parents;


**"WHEREAS,** quality education ensures possible conditions for the fullest development of the pupils given the right opportunities and enough facilities to achieve educational goals; Now, therefore, be it

**RESOLVED AS IT IS HEREBY RESOLVED;** To: Earnestly request the Honorable Alan Peter Cayetano, Senator, Republic of the Philippines to allocate the necessary funds from his Priority Development Assistance Fund (PDAF) to be used for the construction of 3-classroom building at San Roque National High School, Bangkal Annex situated in Barangay San Juan, Municipality of Bulalacao, Province of Oriental Mindoro;




