**RESOLUTION REQUESTING THE NATIONAL FOOD AUTHORITY (NFA),
ROXAS, ORIENTAL MINDORO TO PRIORITIZE PAYMENT OF PALAY
SOLD BY THE LOCAL GOVERNMENT UNIT OF BULALACAO,
ORIENTAL MINDORO**

"WHEREAS, the National Food Authority is vested the functions of ensuring the food security of the country and the stability of supply and price of the staple grain-rice;

"WHEREAS, Bulalacao, is a 3rd class municipality geographically located in the southernmost tip of the Province of Oriental Mindoro and approximately 45 km. away from the nearest NFA warehouse in Roxas, Oriental Mindoro;

"WHEREAS, Bulalacao has a total of 10,325.80 hectares agricultural land area where 22.77 % of it is devoted to rice production, and there are approximately 6,016 individuals employed in agricultural sector;

"WHEREAS, the present crisis in the prices of rice today brought dismay and discontentment to the marginal farmers whose only hope to recover from debt incurred during planting season due to high prices of agricultural inputs and farm labor is the time to harvest;


"WHEREAS, the LGU of Bulalacao understands the struggles of its palay farmers especially in this pandemic, that it facilitates the selling of palay to NFA in a price higher than private traders with an agreement to pay it later however, in consideration of their hard work and to regain their enthusiasm to continue producing palay, it is requested that payment for palay sold be prioritized that would certainly help the farmers to recover from all the expenses and help them and their families enjoy the fruits of their sacrifices; Now, therefore, be it...


