RESOLUTION REQUESTING THE DEPARTMENT OF AGRICULTURE THRU SECRETARY WILLIAM D. DAR TO ALLOCATE FUNDS FOR ADDITIONAL IRRIGATION CANAL IN BARANGAYS CAMBUNANG, MAUJAO, NASUCOB AND SAN JUAN ALL IN THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO

“**WHEREAS**, the Municipality of Bulalacao is well-nigh to being an agro-eco-tourism destination in the Province of Oriental Mindoro, it has a municipal government that aims to establish an efficient local organization which is responsive to the needs of the locality and effectively manages its resources to sustain growth and development;

“**WHEREAS**, because of its location and climate type, Bulalacao is at high risk of weather disturbances and typhoons which causes flooding, storm surges and other damages that affects both agricultural and aquaculture industries, and the safety of the people;

“**WHEREAS**, the four barangays mentioned above are vast agricultural lands producing large volume of rice, corn, garlic and onions and varieties of fruits and vegetables transported to nearby towns and provinces and even in Metro Manila that sufficient supply of water is direly needed to sustain its growth;


“**WHEREAS**, the provision of additional irrigation canal in Barangays Cambunang, Maujao, Nasucob and San Juan would certainly ensure uninterrupted discharge of water that will help the in the irrigation system of the farmers especially now that the municipality is having a drought season;

"WHEREAS, the allocation of funds from the Department of Agriculture would definitely support and help the construction and rehabilitation of the intended irrigation canal that will uphold structural integrity of public facilities and utilities of the municipality as a whole; Now, therefore, be it...
