## RESOLUTION NO. 17-09-205

**RESOLUTION APPROVING SUPPLEMENTAL BUDGET NO. 2 CY 2017 OF BARANGAY CAMPAASAN AMOUNTING TO ONE MILLION NINETY FIVE THOUSAND PESOS (PHP1,095,000.00) PASSED UNDER SANGGUNIANG BARANGAY APPROPRIATION ORDINANCE NO. 17-08-002 DATED AUGUST 17, 2017**

**RESOLVED AS IT IS HEREBY RESOLVED To:** Approve Supplemental Budget No. 2 CY 2017 of Barangay Campaasan amounting to One Million Ninety Five Thousand Pesos (Php1,095,000.00) passed under Sangguniang Barangay Appropriation Ordinance No. 17-08-002 dated August 17, 2017 with the following recommendation, to wit:

1. That, the source of fund shall not be from the Capital Outlay-Improvement of Barangay Hall because the said fund is previously reverted to Unappropriated Fund CY 2017 by virtue of Sangguniang Barangay Ordinance No. 17-08-07 dated August 17, 2017;
2. That, Supplemental Annual Investment Program shall be passed to cover the Construction of Cover of Drainage Canal under 20% Development Fund and Pre-Disaster Equipment, Supplies and Materials under the Barangay Disaster and Risk Reduction Management Plan;
3. That, the procurement of supplies and materials is in accordance with RA 9184 (Government Procurement Reform Act);
4. That, the disbursement of fund shall be in accordance with COA Rules and Regulations;

5. That, compliance with all existing and applicable laws, rules and regulations shall be the sole responsibility of the Sangguniang Barangay of Campaasan in connection with the implementation of said appropriation ordinance.

**RESOLVED FURTHER**, That the Sangguniang Barangay of Campaasan thru the Barangay Secretary, shall be furnished with a copy of this Resolution for its information and guidance.




