EARNESTLY REQUESTING THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT TO KINDLY INCLUDE IN THE DILG KALSADA PROGRAM THE CONCRETING OF SAN ROQUE-BANGKAL-SAN JUAN AND TAFARMA TO SINARAYAN FARM TO MARKET ROADS, ALL OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO IN THE AMOUNT OF ONE HUNDRED FIFTY MILLION PESOS (PHP150M)

“WHEREAS, the Municipality of Bulalacao, Oriental Mindoro is a vast agricultural land that the primary source of income of the residents is farming;

“WHEREAS, the construction and concreting of Farm to Market Roads shall facilitate the movement of people and shipment of various agricultural products such as rice and corn and large varieties of fruits and vegetables from the production site to the market, reducing transportation time and hauling cost thereby preserving its quality for fair market value that would definitely redound to the economic gain of the farmers;

“WHEREAS, the road mentioned above with an approximate length of 8 to 9 kilometers is classified as Provincial Road that its concreting should follow the DPWH standard of 9 inches in depth and 6.7 meters in width with an approximate budget of Php20M per kilometer;

“WHEREAS, the concreting of Farm to Market Road herein mentioned also aims to promote sustainable development among agricultural sector in the country through community-driven development, sustainable rural infrastructure development and agricultural and enterprise development geared towards social and economic growth throughout the countryside; Now, therefore, be it


