**RESOLUTION NO. 17-05-120**

**RESOLUTION REQUESTING THE BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR) THRU MIMAROPA REGIONAL DIRECTOR ELIZER S. SALILIG, MFT TO GRANT EIGHT (8) MOTORIZED PATROL BOATS TO BE USED BY THE BARANGAY FISHERIES AND AQUATIC RESOURCES MANAGEMENT COUNCILS (BFARMC) OF EIGHT (8) COASTAL BARANGAYS OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO**

**"WHEREAS**, the distortion and disturbance of marine life brought by various irresponsible fishing activities have resulted to the vanishing of flora and fauna, destruction of corals and other aquatic life, and critical reduction in marine resource productivity to the detriment of the marginal fisherfolks whose living comes from fishing;

**"WHEREAS**, the Municipal Fisheries and Aquatic Resources Management Council (MFARMC) together with the Barangay Fisheries and Aquatic Resources Management Councils (BFARMC) and the Bantay Dagat of this Municipality joined force to monitor and strictly implement fishery laws and ordinances and apprehend violators in an effort to protect marine life resources;


"WHEREAS, the BFARMCs actively organized in eight (8) coastal barangays of Balatasan, Maasin, Milagrosa, Maujao, San Juan, San Francisco, San Roque and Poblacion, all of the Municipality of Bulalacao each need a patrol boat to be used during patrolling activities especially during night time when unscrupulous persons engaged in irresponsible activities are rampant,

"WHEREAS, in order to fully discharge the duties and functions of BFARMCs, there is a need to provide them with adequate facilities such as that of a patrol boat in an effort to protect our marine resources for the present and future generations; Now, therefore, be it

**RESOLVED AS IT IS HEREBY RESOLVED, To:** Request the Bureau of Fisheries and Aquatic Resources (BFAR) thru MIMAROPA Regional Director Elizer S. Salilig, MFT to grant eight (8) motorized patrol boats to be used by the Barangay Fisheries and Aquatic Resources Management Councils (BFARMC) of eight (8) coastal barangays of the Municipality of Bulalacao, Province of Oriental Mindoro;






