### RESOLUTION NO. 20-09-418

**RESOLUTION REQUESTING THE PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO THRU GOVERNOR HUMERLITO A. DOLOR TO GRANT MONTHLY ALLOWANCES TO SANGGUNIANG KABATAAN KAGAWADS, SECRETARIES AND TREASURERS OF BULALACAO, ORIENTAL MINDORO**

**"WHEREAS**, the 1987 Constitution of the Republic of the Philippines mentions that the State recognizes the vital role of the youth in nation-building and thus, promotes and protects their physical, moral, spiritual, intellectual and social well-being, inculcates in them patriotism, nationalism and other desirable values and encourages their involvement in public and civic affairs;

**"WHEREAS**, Republic Act No. 10742 or the Sangguniang Kabataan Reform Act of 2015 states that there shall be in every barangay a Sangguniang Kabataan to be composed of a chairperson and seven (7) members who shall be elected by the registered voters of the Katipunan ng mga Kabataan. The Sangguniang Kabataan chairperson shall, with the concurrence of the majority of the Sangguniang Kabataan members, appoint from among the members of the Katipunan ng Kabataan, a secretary and a treasurer;

**"WHEREAS**, it has been observed, however, that not all barangays of this municipality have complete set of Sangguniang Kabataan officers as only few individuals had filed certificate of candidacy during the last elections and many would decline being appointed to the positions of secretary and treasurer;

**"WHEREAS**, to provide additional motivation to render services to their fellow youths, granting of allowances or honoraria for actual service rendered by Sangguniang Kabataan kagawads, secretaries, and treasurers is hereby requested;

"WHEREAS, the Local Government of Bulalacao appreciates the efforts of these Sangguniang Kabataan officials and wishes to grant them monthly allowances or honoraria that would somehow compensate even their travelling expenses specially if they are enrolled in learning institutions outside this municipality, and this can be realized thru the very able assistance from the Provincial Government of Oriental Mindoro led by the dynamic, proactive, and hardworking Governor Humerlito "Bonz" Dolor;

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, To; request the Provincial Government of Oriental Mindoro thru Governor Humerlito A. Dolor to grant monthly allowances to Sangguniang Kabataan kagawads, secretaries and treasurers of Bulalacao, Oriental Mindoro.
