WHEREAS, Republic Act No. 11535 is a legislation signed by President Rodrigo Roa Duterte last April 19, 2021, which mandates the creation of the position of Cooperative Development Officer (CDO) in all municipalities, cities and provinces in the country;

WHEREAS, in adherence to the abovementioned mandate, the Local Government Unit of Bulalacao, Oriental Mindoro through the Sangguniang Bayan enacted Municipal Ordinance No. 21-10-300 entitled "Ordinance creating the Municipal Cooperative Development Office of the Local Government Unit of Bulalacao, Oriental Mindoro, defining the qualifications, powers and duties of the Municipal Cooperative Development Officer, and appropriating funds therefor";

WHEREAS, Mr. Dexter R. Gonzales long years of government service was excellent and admirable. He started working in the Local Government Unit of Bulalacao in 1999 as Human Resource Management Officer I, Administrative Officer II in 2006, Supervising Administrative Officer V in 2008 and in 2013, he was elected as Member of the Sangguniang Bayan of Bulalacao where he served for three consecutive terms from 2013-2022;

WHEREAS, the appointee passed the screening and selection processes conducted by the Personnel Selection Board where he appeared to be the lone applicant for the position hence, he was finally appointed as Municipal Cooperative Development Officer by the Local Chief Executive under permanent status on July 1, 2022;

WHEREAS, his appointment was submitted to this Sanggunian for concurrence pursuant to Section 443 of the Local Government Code of 1991 which provides that appointment made by the Local Chief Executive needs concurrence of the majority of all the Sangguniang Bayan Members; **Now, therefore, be it**
