### **RESOLUTION NO. 20-09-414**

**RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 04, SERIES OF 2020 OF BARANGAY BAGONG SIKAT, BULALACAO, ORIENTAL MINDORO ENTITLED "REALIGNING THE AMOUNT OF FIFTEEN THOUSAND PESOS (PHP15,000.00) TAKEN FROM CALAMITY FUND (TRAVELLING EXPENSES AND TRAINING AND SEMINAR) TO AUGMENT SUPPLIES OF BARANGAY BAGONG SIKAT, BULALACAO, ORIENTAL MINDORO" OPERATIVE IN ITS ENTIRETY**

**"WHEREAS**, Section 57 and Section 447 par (li) of RA No. 7160 empower the Sangguniang Bayan to review all ordinances passed by the Sangguniang Barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and not to be inconsistent with law or municipal ordinance;

**"WHEREAS**, Appropriation Ordinance No. 04 series of 2020 of Barangay Bagong Sikat, Bulalacao, Oriental Mindoro entitled "Realigning the amount of fifteen thousand pesos (PhP15,000.00) taken from Calamity Fund (Travelling Expenses and Training and Seminar) to augment supplies of Barangay Bagong Sikat, Bulalacao, Oriental Mindoro" was submitted to this Sanggunian for review on September 1, 2020 pursuant to the provisions of Republic Act (R.A.) 


