RESOLUTION NO. 20-09-413

RESOLUTION INFORMING THE PROVINCIAL AGRICULTURE OFFICE, ORIENTAL MINDORO THRU THE PROVINCIAL AGRICULTURIST, MS. CHRISTINE M. PINE THAT THERE IS AN OUTBREAK OF RICE INFESTATION OCCURRING IN THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO AND FURTHER SEEKING IMMEDIATE TECHNICAL ASSISTANCE TO CONTROL AND PREVENT THE SPREAD OF THESE PATHOGENIC MICROORGANISMS

"WHEREAS, Section 2 of Republic Act No. 10068 states that "It is hereby declared the policy of the state to promote, propagate, develop further and implement the practice of organic agriculture in the Philippines that will cumulatively condition and enrich the fertility of the soil, increase farm productivity; reduce pollution and destruction of the environment, prevent the depletion of natural resources, further protect the health of farmers, consumers and the general public, and save program for the promotion of community-based organic fertilizers such as compost, pesticides and other farm inputs, together with a nationwide educational and promotional campaign for their use and processing, as well as the adoption of organic agricultural system as viable alternative shall be undertaken";

"WHEREAS, Bulalacao, a third class municipality is a vast agricultural land, has 15 barangays and with a total agricultural land area of 10,325.80 hectares where 6,016 individuals are employed in the agricultural sector;

"WHEREAS, it is alarming because Bulalacao is experiencing an outbreak of rice infestation where Brown Plant Hoppers (BPH) and White Plant Hoppers (WPH) are attacking rice plants particularly the leaves that might totally damage the plants leading to zero production;

"WHEREAS, since farming is one of the primary means of income and livelihood of Bulalacaonons, it is important to discard these pests the soonest time as possible to protect farmers against huge agricultural losses;


"WHEREAS, it is hoped that rice infestation being experienced at present, may not brought adverse effects in the planting season of onions in the coming months;

NOW, THEREFORE, BE IT, RESOLVED AS IT IS HEREBY RESOLVED, To: inform the Department of Agriculture, Oriental Mindoro thru the Provincial Agriculturist Christine M. Pine that there is an outbreak of rice infestation occurring in the Municipality of Bulalacao, Oriental Mindoro and further seek immediate technical assistance to control and prevent the spread of these pathogenic microorganisms.
