EARNESTLY REQUESTING SECRETARY ALFONSO CUSI, DEPARTMENT OF ENERGY TO RETAIN THE EMERGENCY POWER FACILITY IN ORMECO, BARANGAY ODIONG, MUNICIPALITY OF ROXAS, ORIENTAL MINDORO WHICH SUPPLY ELECTRICITY FOR ROMANBUL

"WHEREAS, the installation of emergency power facility in ORMECO, Roxas a few years ago consisting of seven (7) modular operating units with a total rated capacity of 8.6 mw and a total dependable capacity of 5.3 mw ensure the regulated supply of electricity in the southern part of Oriental Mindoro particularly the Municipalities of Roxas, Mansalay and Bulalacao;

"WHEREAS, notice of termination of these emergency power facility was received by this Body to which in consideration of the economic benefits it may cause to household and industries and in addition to the maintenance of peace and order brought by streetlights during night time and such other activities propelled by electricity, its termination shall greatly cause major adverse efforts to our people and the community;

"WHEREAS, the continuous operation of the Emergency Power Facility of the Mindoro Grid Corporation (MG) shall ensure the efficient and reliable supply of electricity to ROMANBUL Municipalities that are necessary in its for social and economic growth; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request Secretary Alfonso Cusi, Department of Energy to retain the Emergency Power Facility in ORMECO, Barangay Odiong, Municipality of Roxas, Oriental Mindoro which supply electricity for ROMANBUL;




