RESOLUTION NO. 21-03-106

EARNESTLY REQUESTING THE PROVINCIAL AGRICULTURE OFFICE, ORIENTAL MINDORO THROUGH THE PROVINCIAL AGRICULTURIST, MS. CHRISTINE M. PINE TO EXTEND ANY KIND OF ASSISTANCE TO THE ONION FARMERS OF THE MUNICIPALITY OF BULALACAO WHOSE PLANTS WERE BADLY DAMAGED BY INFESTATION CAUSED BY INFECTIOUS DISEASE

“WHEREAS, Section 2 of Republic Act No. 10068 states that “It is hereby declared the policy of the state to promote, propagate, develop further and implement the practice of organic agriculture in the Philippines that will cumulatively condition and enrich the fertility of the soil, increase farm productivity; reduce pollution and destruction of the environment, prevent the depletion of natural resources, further protect the health of farmers, consumers and the general public, and save program for the promotion of community-based organic fertilizers such as compost, pesticides and other farm inputs, together with a nationwide educational and promotional campaign for their use and processing, as well as the adoption of organic agricultural system as viable alternative shall be undertaken”;

“WHEREAS, Bulalacao, a 3rd class municipality is a vast agricultural land, has 15 barangays and with a total agricultural land area of 10,325.80 hectares where 6,016 individuals are employed in the agricultural sector;

“WHEREAS, Bulalacao has a tropical climate and is popular in producing large volume of onions where all efforts of diligent farmers are exerted to have these planted every year, these products are being transported to Manila and adjacent provinces;

“WHEREAS, it is unfortunate that because of the plant infestation and unknown damages, many Bulalacaonon onion farmers at this present time are experiencing massive losses in production that disheartens them and made no hope to have income to provide and support their families;

"WHEREAS, the provision of any kind of assistance to the affected onion farmers of this municipality would help in regaining their enthusiasm to continue planting onions that will not only be helpful for their own livelihood, but also to the benefits of the municipality as a whole;

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, To; earnestly request the Provincial Agriculture Office, Oriental Mindoro through the Provincial Agriculturist, Ms. Christine M. Pine to extend any kind of assistance to the onion farmers of the Municipality of Bulalacao whose plants were badly damaged by infestation caused by infectious disease.
