RESOLUTION NO. 21-03-105

RESOLUTION REQUESTING THE HARIBON FOUNDATION TO RENDER TECHNICAL, TECHNOLOGICAL, AND FINANCIAL ASSISTANCE TO THE LOCAL GOVERNMENT UNIT OF BULALACAO IN ESTABLISHING CRITICAL HABITATS OF WILD FLORAL AND FAUNAL SPECIES IN BULALACAO, ORIENTAL MINDORO

“WHEREAS, Section 2 of Republic Act No. 9147 otherwise known as the Wildlife Resources Conservation and Protection Act states that “It shall be the policy of the State to conserve the country’s wildlife resources and their habitats for sustainability. The following objectives of this Act are to conserve and protect wildlife species and their habitats to promote ecological balance and enhance biological diversity; to regulate the collection and trade of wildlife; to pursue with due regard to the national interest, the Philippine commitment to international conventions, protection of wildlife and their habitats; and to initiate or support scientific studies on the conservation of biological diversity”;

“WHEREAS, the Haribon Foundation is a nature conservation membership organization founded in 1972 dedicated to works in a wide variety of areas in establishing community-led native tree nurseries or strengthening marine protected areas by applying science with community-driven principles it conserves sites and habitats, it also conducts research on biodiversity to reveal mysteries behind some of the country’s most unique wildlife and their connections to the habitats people share with them;

“WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro is on the borderline to being an eco-agro-tourism hub in the Province of Oriental Mindoro, it has a strategic location in MIMAROPA region and is very rich in Panay, Caluya and Semirara Islands where there are multiple wildlife and endangered species reported that shall be protected;

"WHEREAS, Bulalacao is indeed rich in wildlife species and natural resources both in forest land and marine environment, there have been a report that there are wild animals like civet cat(musang), monkey, woodpecker and other rare types of birds found in Sitio Banti, Barangay San Roque, this Municipality and based on the inventory done in Buyayao Island there are still wild and distinct animals living in the island;

"WHEREAS, the Local Government Unit of Bulalacao is planning to establish critical habitats that would provide shelter and adequate care and protection to the confiscated, donated, impounded and/or abandoned wild floral and faunal species, thus it is in need of technical, technological, and financial assistance to support and achieve this plan;

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, To: Request the Haribon Foundation to render technical, technological, and financial assistance to the Local Government Unit of Bulalacao in establishing critical habitats of wild floral and faunal species in Bulalacao, Oriental Mindoro.
