**RESOLUTION REQUESTING SECOND DISTRICT REPRESENTATIVE

EXTEND THE NEEDED INTERVENTION IN GRANTING ONE UNIT DUMP  
TRUCK TO EVERY BARANGAY OF BULALACAO, ORIENTAL MINDORO**

**"WHEREAS**, Section 17 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that local government units shall likewise exercise such other powers and discharge such other functions and responsibilities necessary, appropriate, or incidental to efficient and effective provision of basic services and facilities;

**"WHEREAS**, Bulalacao is a third class municipality with a population of 39, 107 based on 2015 census, has 15 barangays dispersed in its distinctive geography bounded by seas and mountains;


**"WHEREAS**, each barangay of this municipality is in need of a dump truck that would serve as a multi-purpose vehicle;
