RESOLUTION NO. 20-09-390

RESOLUTION REQUESTING THE DEPARTMENT OF HEALTH TO INCLUDE IN ITS PRIORITY PROJECTS FOR THE YEAR 2021 AND BEYOND THE CONSTRUCTION OF HEALTH STATIONS IN BIG SITIOS PARTICULARLY IN MANGYAN COMMUNITIES IN THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO

"WHEREAS, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare, within their respective territorial jurisdictions, local government units shall promote health and safety;

"WHEREAS, Bulalacao, a 3rd class municipality located at the southernmost tip of the Province of Oriental Mindoro, is composed of approximately 25 percent indigenous people called Hanunuo Mangyans living in the hinterland. Because of poverty they have no access to basic medical care and services;

"WHEREAS, community health stations deliver basic health care and services to the nation's most vulnerable individuals and families, including those who are homeless, agricultural workers, residents of public housing project, senior citizens, women and children, and indigenous people;


"WHEREAS, it is important to construct health stations that are community-based and patient-directed in order to deliver comprehensive primary health care services, improve access to medicines and support services, and facilitate health education in the following sitios, to wit:

- i. Barangay Nasucob - Sitios Upper Yunot, Pawikan, Abintang, and Suryawon.
- ii. Barangay San Roque - Sitios Gatol, Badyang, Bar-aw, Agong, Arasaas, Dangkalan and Ambulong.
- iii. Barangay Benli - Sitios Umabang, Bailan, Waring, Kalatas, Balditan, Silad, Balagway, Hamloy, Karumata, and Balang.
- iv. Barangay Balatasan - Sitio Dakutan.
- v. Barangay Milagrosa - Sitios Buol, Bating, Alimango.
- vi. Barangay Cambunang - Sitios Bagong Silang

NOW, THEREFORE, BE IT, RESOLVED AS IT IS HEREBY RESOLVED, To: request the Department of Health to include in its priority projects for the year 2021 and beyond the construction of health stations in big sitios particularly in mangyan communities in the Municipality of Bulalacao, Oriental Mindoro.
