RESOLUTION REQUESTING THE DEPARTMENT OF HEALTH-CENTER FOR HEALTH DEVELOPMENT (DOH-CHD), REGION IV-MIMAROPA TO FACILITATE THE IMMEDIATE DEPLOYMENT OF ANOTHER DOCTOR TO THE BARRIO IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO IN LIEU OF DR. RAFAEL C. CRUZ WHOSE CONTRACT WILL BE TERMINATED ON NOVEMBER 5, 2020

"WHEREAS, it is a Constitutional mandate that the State may issue some regulatory requirements to promote health in rural communities such as the policy of making rural service for some doctors must be given priority and preferential treatment;

"WHEREAS, it has been proven in the previous years that rural medical services rendered by the Doctors to the Barrio was of great help in alleviating the health condition of the rural impoverished communities giving them access to various medical needs and services;

"WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro is composed of twenty four percent hanunuo mangyans living in the mountainous area where existing alarming health hazards such as malaria, filiarisis and dengue needs immediate medical attention to protect these vulnerable group of the community;

"WHEREAS, the contract of service of Dr. Rafael C. Cruz, the present Doctor to the Barrio at this Municipality will be terminated on November 5, 2020 that another deployment of one (1) Doctor to the Barrio is highly needed considering the global public health crisis caused by Covid-19 pandemic which poses the loss of precious human lives;; **Now, therefore, be it**

RESOLVED AS IT IS HEREBY RESOLVED, To: Request the Department of Health-Center for Health Development (DOH-CHD), Region IV-MIMAROPA to facilitate the immediate deployment of another Doctor to the Barrio in the Municipality of Bulalacao, Province of Oriental in lieu of Dr. Rafael C. Cruz whose contract will be terminated on November 5, 2020;






