“WHEREAS, farm to market roads increase local trade and productivity, reduce transportation costs of farm inputs and outputs and minimize post harvest losses. A good transportation system enables agriculture and emboldens the farmers to invest more and increase production;

“WHEREAS, pursuant to Administrative Order No. 16, series of 2020, the Department of Agriculture is mandated to undertake various infrastructure projects such as farm to market roads among others in order to provide better opportunities to farmers by increasing farm production at lower cost and hereby increasing their income and making food more affordable to the general public;

“WHEREAS, under this mandate, the General Appropriations Act (GAA) provides annual appropriations for FMR under the Department of Agriculture budget which will be used for the construction, repair and rehabilitation of FMR which will be directly released to the Department of Public Works and Highways upon recommendation of the DA;

"WHEREAS, the proposed roads networks in the Municipality of Bulalacao as identified during the formulation of the LGU Annual Investment Plan and Local Development Plan are generally located in the geographically isolated and depressed areas that concreting of these roads would encourage participation in all aspects of life, address insurgency problems to stimulate social and economic development; **Now, therefore, be it**
