RESOLUTION NO. 20-06-306

EARNESTLY REQUESTING THE PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO THROUGH GOVERNOR HUMERLITO A. DOLOR TO GRANT 150 UNITS OF HANDHELD TWO-WAY RADIOS TO BE DISTRIBUTED TO EACH BARANGAY TANOD OF FIFTEEN COMPONENT BARANGAYS OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, the Municipality of Bulalacao is located in the southernmost tip of the Province of Oriental Mindoro flanked by high mountain ranges with very rugged terrain configurations in some areas. It has eight (8) coastal barangays separated by sea where communication is really difficult particularly during emergency cases and the onslaught of bad weather condition;

"WHEREAS, everyone would agree that the most critical component during emergency situation is access to communication that internet based forms of communications will likely go down for some reasons but as long as the two-way radios are not damaged, it will continue to work long past other forms of communications, that is why, a two-way radio can be life changing in the instance of an emergency;

"WHEREAS, here are the following benefits of using two-way radios instead of mobile phones:

- i. Service during emergencies- all service towers and landline may fail during an emergency but a two-way radio will continue to work;
- ii. Lightweight durability- two-way radios are designed to be lightweight and long-lasting. Mobile phones require a protective case;

- iii. Cost effective- two-way radios cost less than all phones;
- iv. Communication clarity-two-way radios are designed to offer clear communications in most conditions;
- v. Ease of use- two-way radios feature touch button talk communication which simplify the process of copying radio settings.

"WHEREAS, taking into consideration the topographical condition of Bulalacao, Oriental Mindoro, the provision and use of the handheld two-way radios to its fifteen component barangays through its barangay officials shall be the best instrument for better coordination and mutual understanding and cooperation towards a common good; **Now, therefore, be it**

RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request the Provincial Government of Oriental Mindoro through Governor Humerlito A. Dolor to grant 150 units of handheld two-way radios to be distributed to each barangay tanod of fifteen barangays of the Municipality of Bulalacao, Province of Oriental Mindoro;
