EARNESTLY REQUESTING THE HONORABLE HUMERLITO A. DOLOR, PROVINCIAL GOVERNOR, PROVINCE OF ORIENTAL MINDORO TO ALLOCATE THE NECESSARY FUNDS TO BE USED FOR THE REPAIR AND REHABILITATION OF FOOTBRIDGE IN SITIO COGON MALAPAD, BARANGAY CAMBUNANG, BULALACAO, ORIENTAL MINDORO

"WHEREAS, rural communities have demonstrated that access to reliable pedestrian transportation infrastructure such as a "footbridge" can have dramatic effects on the ability of the residents to meet their own needs, care for their families, earn stable income and build resiliency against unpredictable weather;

"WHEREAS, a footbridge in Sitio Cogon Malapad is connecting Barangay Cambunang and Barangay Nasucob which are both producing large volume of agricultural products such as rice, corn, garlic and onion and huge varieties of fruits and vegetables;

"WHEREAS, the footbridge mentioned above was heavily damaged by Typhoons Tisoy and Ursula in December, 2019 that its immediate repair is needed to facilitate the movement of people and shipment of goods;

"WHEREAS, hounded with financial constraints, the only hope to realize the project mentioned above is through the kindness and benevolence of the Provincial Government; **Now, therefore, be it**




