RESOLUTION RECOMMENDING TO THE HONORABLE EDRALIN C. REYES, PRESIDING JUDGE, REGIONAL TRIAL COURT, FOURTH JUDICIAL REGION, ORIENTAL MINDORO BRANCH XLIII, ROXAS, ORIENTAL MINDORO THE APPOINTMENT OF MR. EDEZER F. ACERON AS NOTARY PUBLIC FOR AND IN BULALACAO, ORIENTAL MINDORO

"WHEREAS, Mr. Edezer F. Acheron graduated in the University of Santo Tomas with the degree of Bachelor of Arts Major in Philosophy and graduated Bachelor of Law in the University of the East;

"WHEREAS, he was a former Graft Investigation Officer of the Office of the OMBUDSMAN, Municipal Administrator of the Local Government Unit of Bulalacao, a Career Service Professional eligible and the incumbent Sangguniang Bayan Member of Bulalacao, Oriental Mindoro;

"WHEREAS, there was no Lawyer-Notary Public in Bulalacao, Oriental Mindoro due to the retirement of Atty. Edgardo C. Acheron from notarial practice and did not renew his appointment as Notary Public that expired on November 1, 2019;

"WHEREAS, as a result of this, people in this Municipality who have some transactions to be prepared have still to go to Mansalay or Roxas, Oriental Mindoro or in San Jose, Occidental Mindoro for the purpose of having their documents notarized, thus entailing expenses and suffering the inconvenience of travel;

"WHEREAS, Sec. 233 (Title IV, Chapter II, Revised Administrative Code) states that in Municipalities or Municipal Districts where no person resides having the qualifications hereinbefore specified or having them refuse to hold such office, judges of first instance may appoint other persons temporarily to exercise the office of notary public who have the requisite qualifications of fitness and morality; **Now, therefore, be it**

RESOLVED AS IT IS HEREBY RESOLVED, To: Recommend to Honorable Edralin C. Reyes, Presiding Judge, Regional Trial Court, Fourth Judicial Region Branch XLIII, Roxas, Oriental Mindoro, the appointment of Mr. Edezer F. Aceron as Notary Public for and in Bulalacao, Oriental Mindoro as an exceptional case in the interest of public service;
