EARNESTLY REQUESTING THE PHILIPPINE RECLAMATION AUTHORITY TO GRANT SPECIAL PERMIT TO THE LOCAL GOVERNMENT UNIT OF BULALACAO, PROVINCE OF ORIENTAL MINDORO FOR RECLAMATION OF BULALACAO BAY IN PREPARATION FOR THE PROPOSED CONSTRUCTION OF BULALACAO BAY VIEW PARK

"WHEREAS, the Philippine Reclamation Authority (PRA) is a government-owned and controlled corporation tasked with regulating and approving all reclamation projects in the country. It is a development agency which according to its website has created assets for the Government by converting reclaimed lands into valuable and income-generating real estate properties;

"WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro is emerging into an agro-tourism community full of wonderful tourist destinations such as beautiful islands and islets with crystal clear waters and powdery white sand beaches, amazing water falls and high mountain ranges perfect for hiking and mountain trekking;
