RESOLUTION NO. 20-05-257

RESOLUTION REQUESTING SENATOR CHRISTOPHER "BONG" GO TO ALLOCATE FUND FOR THE CONSTRUCTION OF A COAST GUARD BUILDING AT BULALACAO RORO PORT, BULALACAO, ORIENTAL MINDORO

WHEREAS, pursuant to Section 12 of Republic Act 7160 otherwise known as the Local Government Code of 1991 states that "Provinces, cities, and municipalities shall endeavor to establish a government center where offices, agencies, or branches of National Government, local government units, or government-owned or -controlled corporations may, as far as practicable, be located. In designating such a center, the local government unit concerned shall take into account the existing facilities of national and local agencies and offices which may serve as the government center as contemplated under this Section. The National Government, local government unit or government – owned or controlled corporation concerned shall bear the expenses for the construction of its buildings and facilities in the government center";

WHEREAS, pursuant to Republic Act 9993, the Philippine Coast Guard (PCG) is mandated to enforce regulations in accordance with all relevant maritime international conventions, treaties or instruments of which the government is signatory and national laws, one of its function is to help prevent or minimize unnecessary loss of lives and properties at sea, also it is the sole agency responsible for the Philippine implementation of the conventions with regards to oil pollution, prevention, mitigation and control through the conduct of marine pollution monitoring and control, enhancement of PCG capability and oil spill response operations and enforcement of all marine environmental laws and regulations;

WHEREAS, in accordance to Executive Order No. 370 the Municipality of Bulalacao is considered as a 3rd class municipality, it is located at the southernmost tip of the Province of Oriental Mindoro, roughly a 3 to 4 hour

drive (176 kilometers) from the provincial capital of Calapan City, it is enclosed by the Bulalacao Bay and Tablas Strait;

WHEREAS, the Municipality of Bulalacao now have its own seaport established as Bulalacao RoRo Port, it is ideating itself as part of a Premier Tourism Triangle together with Boracay and Palawan, it is directly linked to Caticlan, Aklan and Semirara Island, Caluya, Antique, and is planning to launch a new ferry route heading directly to Coron, Palawan;

WHEREAS, at this present time the Municipality of Bulalacao is in lack of office and/or building for the coast guard personnel, hence the Local Government of Bulalacao already identified and allotted a lot within the area of Bulalacao RoRo Port to construct the said building, **Now, therefore, be it;**

RESOLVED AS IT IS HEREBY RESOLVED, To: Request Senator Christopher "Bong" Go to allocate fund for the construction of a Coast Guard Building at Bulalacao RoRo Port, Bulalacao, Oriental Mindoro.
