RESOLUTION ENDORSING THE ESTABLISHMENT OF THE MANGYAN HERITAGE AND CULTURAL CENTER OF ORIENTAL MINDORO WITH A PROJECT COST AMOUNTING TO FIFTEEN MILLION PESOS (PHP15M) TO THE NATIONAL ECONOMIC AND DEVELOPMENT AUTHORITY (NEDA) FOR INCLUSION AS PRIORITY PROJECT UNDER THE SUSTAINABLE DEVELOPMENT GOAL (SDG) AGENDA II THROUGH THE NATIONAL COMMISSION FOR CULTURE AND THE ARTS (NCCA) SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS

“WHEREAS, the Mangyan Heritage Center is a library, archive and research and education center that promotes awareness of the indigenous peoples of the Island of Mindoro called the mangyans;

“WHEREAS, the Center hosts a travelling exhibit, the mangyans of Mindoro myth and weaving. The exhibit includes traditional cotton spinning and weaving demonstration by mangyan girls, beaded bracelet making workshops and a script writing exercise in hanunuo mangyan script;

“WHEREAS, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 mandates that every local government unit shall promote the general welfare such as the preservation and enrichment of culture among other;

“WHEREAS, the Municipality of Bulalacao is composed of approximately twenty four percent hanunuo mangyans which offers rich artistic heritage to the history of pre-colonial Philippines that the establishment of mangyan Heritage and Cultural Center of Oriental Mindoro to be known as Mangyan Center is indispensable;

“WHEREAS, hounded with financial constraints the above noble objective is believed to be realized thru the assistance of the higher government agency such as the National Economic and Development Authority; **Now, therefore, be it**

RESOLVED AS IT IS HEREBY RESOLVED, To: Endorse the establishment of the Mangyan Heritage and Cultural Center of Oriental Mindoro with a project cost amounting to fifteen million pesos (PhP15M) to the National Economic and Development Authority (NEDA) for inclusion as priority project under the Sustainable Development Goal (SDG) Agenda II through the National Commission for Culture and the Arts (NCCA) subject to existing laws, rules and regulations;




