### **RESOLUTION NO. 20-02-183**

**RESOLUTION REQUESTING THE LAND TRANSPORTATION OFFICE TO CONDUCT TRAINING FOR TRAFFIC ENFORCERS HIRED BY THE LOCAL GOVERNMENT UNIT OF BULALACAO, ORIENTAL MINDORO AND BARANGAY TANODS ON IMPLEMENTATION OF TRAFFIC RULES AND REGULATIONS AND TO DEPUTIZE ADDITIONAL TRAFFIC ENFORCERS TO THIS MUNICIPALITY**

**"WHEREAS**, the Land Transportation Office (LTO) is a sectoral agency of the Department of Transportation (DOTr) by virtue of Executive Order No. 125 and 125A dated April 13, 1987 and Executive Order No. 226 dated July 25, 1987, tasked to register motor vehicles, issue driver's/conductor's licenses and permits, enforce transportation laws, rules and regulations and adjudicate apprehension cases;

**"WHEREAS**, the Municipality of Bulalacao, Province of Oriental Mindoro is in the borderline of having all the roadways concrete and accessible that the number of vehicles continuously increases and in order to maintain tranquil and orderly traffic flow it is best to provide training for traffic enforcers hired by the Local Government Unit of Bulalacao, Oriental Mindoro and barangay tanods on implementation of traffic rules and regulations;


**"WHEREAS**, the Municipality of Bulalacao, Province of Oriental Mindoro is composed of 15 barangays that have many dissimilar roads and intersections, it is best to have additional LTO-deputized traffic enforcers to implement traffic rules and regulations properly; **Now, therefore, be it**


