RESOLUTION REQUESTING THE SANGGUNIANG PANLALAWIGAN OF ORIENTAL MINDORO THRU THE PRESIDING OFFICER, VICE GOVERNOR ANTONIO "JOJO" PEREZ TO INCLUDE IN ITS ANNUAL INVESTMENT PLAN (AIP), COMPREHENSIVE DEVELOPMENT PLAN (CDP) AND LOCAL DEVELOPMENT INVESTMENT PLAN (LDIP) THE CONSTRUCTION OF BALATASAN RECLAMATION/OPEN SPACE AND BAYSIDE ACCESS ROAD FROM THE RESIDENCE OF MR. CONSTANCIO MENDOZA TO SITIO PINTOR AND FROM SITIO LAWIGAN- BUBOG-TAKASAN IN BARANGAY BALATASAN, BULALACAO, ORIENTAL MINDORO

"WHEREAS, the Municipality of Bulalacao is a 3rd class municipality located at the southernmost tip of the Province of Oriental Mindoro that has distinct geographical features with a population of approximately 25 percent indigenous people called Hanunuo Mangyan;

"WHEREAS, Bulalacao is well-nigh to being an agro-eco-tourism destination in the Province of Oriental Mindoro, it has a municipal government that aims to establish an efficient local organization which is responsive to the needs of the locality and effectively manages its resources to sustain growth and development;

"WHEREAS, the Local Government Unit of Bulalacao is focused and steadfast in improving the physical development and economic advancement of the municipality as a whole by doing access roads and infrastructure projects that are beneficial to its people;

"WHEREAS, Balatasan is one of the progressing barangays in Bulalacao in terms of marine business, cooperatives and tourism, thus certain areas and open spaces as mentioned above are badly needed of construction and improvement for better use of its residents;

"WHEREAS, to further accomplish its construction and improvement, the Local Government Unit of Bulalacao would need technical help and financial support from the Provincial Government of Oriental Mindoro; Now, therefore, be it...
