**RESOLUTION REQUESTING CONGRESSMAN ALFONSO V. UMALI, JR.,
2ND DISTRICT REPRESENTATIVE, PROVINCE OF ORIENTAL MINDORO
TO ALLOCATE FUNDS FOR THE CONSTRUCTION OF SEAWALL ALONG
THE COASTAL AREA OF BARANGAY BALATASAN, BULALACAO,
ORIENTAL MINDORO**

"WHEREAS, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare, within their respective territorial jurisdictions, local government units shall promote health and safety;

"WHEREAS, Bulalacao, a 3rd class municipality located at the southernmost tip of Oriental Mindoro, it has 15 barangays 8 of which are coastal barangays, and has a municipal government that aims to establish an efficient local organization which is responsive to the needs of the locality and effectively manages its resources to sustain growth and development;

"WHEREAS, because of its location and climate type, Bulalacao is at high risk of weather disturbances and typhoons which causes flooding, storm surges and other damages that affects both agricultural and aquaculture industries, and the safety of the people;

"WHEREAS, Balatasan is one of the coastal barangays of Bulalacao, it is important to construct a seawall along its coastal area that would protect its inland area against wave action, and it is a massive structure that could prevent coastal erosion and would protect people from heavy storm surges;

"WHEREAS, the provision of seawall in the coastal area of Barangay Balatasan would not only be beneficial for its resident but it would also support in upholding the structural integrity of public facilities and utilities of the municipality as a whole; Now, therefore, be it...
