MARCOS, JR., PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES AND SECRETARY OF THE DEPARTMENT OF AGRICULTURE TO PROVIDE TECHNICAL AND FINANCIAL ASSISTANCE FOR THE PROPAGATION OF CASSAVA, CASHEW, MANGO, SWEET POTATO, TURNIPS AND OTHER CROPS THAT CAN WITHSTAND LONG PERIOD OF DRY SEASON IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO**

**"WHEREAS**, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare, within their respective territorial jurisdictions;

**"WHEREAS**, Bulalacao, a 3<sup>rd</sup> class municipality is a vast agricultural land, has 15 barangays where some are home to indigenous people called Hanunuo-Mangyans, has a total agricultural land area of 10,325.80 hectares where 6,016 individuals are employed in the agricultural sector;

"WHEREAS, Bulalacao has agricultural barangays that has tropical climate conducive to planting cassava, cashew, mango, sweet potato, turnips and other crops that can withstand long period of dry season which have been its primary means of income and livelihood;

"WHEREAS, provision of technical assistance and farmers support fund are needed to secure the maintenance and/or increase of productivity and profitability of its farmers that would be beneficial not only to their livelihood but also to the local agricultural income; Now, therefore, be it...

**RESOLVED AS IT IS HEREBY RESOLVED, To:** Request His Excellency Ferdinand "Bongbong" R. Marcos, Jr., President of the Republic of the Philippines and Secretary of the Department of Agriculture to provide technical and financial assistance for the propagation of cassava, cashew, mango, sweet potato, turnips and other crops that can withstand long period of dry season in the Municipality of Bulalacao, Province of Oriental Mindoro,




