RESOLUTION REQUESTING THE DEPARTMENT OF AGRICULTURE THRU SECRETARY WILLIAM D. DAR TO CONDUCT OCULAR INSPECTION TO FACILITATE THE CONSTRUCTION OF SITIO KALONG-DACUTAN-NABUGTUAN-BADYANG-KAPULAWAN-BASACAR-GAMOT-BUNGA-BURBO-BISLIG FARM-TO-MARKET ROADS, ALL IN BARANGAY BALATASAN, BULALACAO, ORIENTAL MINDORO

"WHEREAS, the Municipality of Bulalacao is a 3rd class municipality located at the southernmost tip of the Province of Oriental Mindoro that has distinct geographical features with a population of approximately 25 percent indigenous people called Hanunuo Mangyan;

"WHEREAS, Bulalacao is well-nigh to being an agro-eco-tourism destination in the Province of Oriental Mindoro, it has a municipal government that aims to establish an efficient local organization which is responsive to the needs of the locality and effectively manages its resources to sustain growth and development;

"WHEREAS, the Local Government Unit of Bulalacao is focused and steadfast in improving the agricultural development and economic advancement of the municipality as a whole by doing road infrastructure projects that are beneficial to its people;

"WHEREAS, the farm-to-market roads of Sitios Kalong, Dacutan, Nabugtuan, Badyang, Kapulawan, Basacar, Gamot, Bunga, Burbo and Bislig in Barangay Balatasan which are also homes to most of Hanunuo Mangyans are needed to have ocular inspection that would auspiciously results to its construction;
