"WHEREAS, roads are of vital importance in order to make a nation grow and develop. It provides access to employment, social, health and education services which makes a road network crucial in fighting against poverty. Roads open up more areas and stimulate economic and social development;

"WHEREAS, the main characteristic of the construction of roads is connecting people from different parts of the community in order to ensure their participation in all aspects of life together with the free movement of goods, services and people;

"WHEREAS, the construction of roads connecting from one sitio to another particularly in geographically isolated and depressed areas such as Barangay San Roque as mentioned hereunder is important to address insurgency problem because it limits their violent activities in the area; to wit:

- i. Construction of FMR from Sitio Libtong, Barangay San Roque to Barangay San Juan;
- ii. Concreting of road from Sitio Dangkalan to Sitio Bahungan to Sitio Libtong, Barangay San Roque;
- iii. Concreting of road from the national highway to San Roque Cemetery;
- iv. Concreting of road from national highway to Sitio Badyang, Barangay San Roque;

"WHEREAS, Barangay San Roque has great tourism potentials such as the Pocanil and the famous Buyayao Island that an all-weathered road is indispensable to boost its tourism industry; **Now, therefore, be it**
