### ORDINANCE NO. 09-08-102

AMENDING SECTION 2 OF ORDINANCE NO. 08-07-83 ENTITLED  
 "ORDINANCE ADOPTING EXECUTIVE ORDER NO. 305 DEVOLVING TO  
 THE MUNICIPAL GOVERNMENT THE REGISTRATION OF FISHING  
 VESSELS THREE (3) GROSS TONNAGE AND BELOW" AND FURTHER  
 ADDING ANOTHER SECTION PROVIDING PENALTIES IN VIOLATION  
 THEREOF

**BE IT ORDAINED** by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:


**SECTION 1.** Section 2 of Ordinance No. 08-07-83 entitled "An Ordinance adopting Executive Order No. 305 devolving to the Municipal Government the registration of fishing vessels three (3) gross tonnage and below" is hereby amended to be read as follows:

**"Sec. 2.** The Sangguniang Bayan shall formulate the necessary implementing rules and guidelines consistent with the herein adopted Executive Order No. 305"


**SEC. 2.** Any person violating this Ordinance shall suffer the penalty of not less than one (1) month but not more than six (6) months imprisonment or shall be fined by an amount of not less than Two Hundred Pesos (Php200.00) but not more than Two Thousand Five Hundred Pesos (Php2,500.00) or both such fine and imprisonment at the discretion of the Court;


SEC.3. This Ordinance shall take effect upon approval.


